Voting Open for 2021 CTPF Board of Trustees Elections

Voting is now open in the 2021 CTPF Board of Trustee Elections and closes at 5:00 p.m. on November 5, 2021. Voting credentials were mailed to members' home addresses on October 18, 2021, and YesElections, the Fund's election agent, will also send emails to members with voting credentials. All Teacher Trustee voting will be conducted online.

Pension Rep Webinars

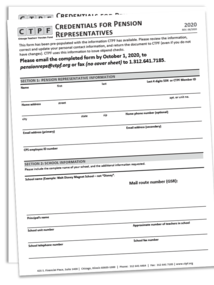

2021 Election Changes

CTPF is holding an election for two Teacher Trustees who will serve three-year terms from November 2021-2024. The CTPF Board of Trustees changed the Election Policy to allow the collection of petition signatures online, the distribution of voting credentials by U.S. Mail, and the opening of the voting site the day materials are mailed.
