## **Changes to Voting in Pensioner Trustee Election**

Due to US Postal Service mail delays, CTPF is extending the date to return ballots in the **Pensioner Trustee Election.** All ballots must now be **postmarked** by November 6, 2021, and **received** by the Election agent by 5:00 p.m. (CT) on November 12, 2021. CTPF will also offer two drop box locations for pensioners who want to return their ballots locally. This change does NOT impact the Teacher Trustee election, see below for more information.

## 2022 Open Enrollment Period Closes October 31

The 2022 Open Enrollment Period will run from October 1-31, 2021. During this time, annuitants can enroll, add or drop a dependent, or change a health insurance plan or carrier. Changes become effective January 1, 2022.

#### **2022 Premium Subsidy**

The Board of Trustees voted to continue the Health Insurance Premium Subsidy at **60%** for 2022.

#### **Open Enrollment: What Not To Do**

While the CTPF Open Enrollment period ends October 31, the Medicare Open Enrollment period began October 15 and runs through December 7. During this annual window, Medicare eligible participants can enroll in coverage. However, if you enroll through one of the many plans advertised heavily on television, radio, social media, or multiple solicitations, you will be **disenrolled** from your CTPF health insurance plan. If you later decide that you are unhappy with a non-CTPF plan and want to rejoin a CTPF plan, you must wait until the next Open Enrollment period, unless you have a qualifying event. You can only rejoin a CTPF plan without a qualifying event once in your lifetime. Find more information here.

## **Chicago Teachers' Pension Fund Now Includes CPS Contract School Employees**

Legislation enacted July 1, 2021, changed the retirement plan requirements for educational staff employed by a Chicago contract school in a position requiring certification or licensure. Individuals employed in contract schools on or after July 1, 2021, will be automatically enrolled in the Chicago Teachers' Pension Fund. ### **Return to Work Rules Modified**

At the September 23, 2021, meeting the CTPF Board of Trustees took action and amended the Return to Work Rules to define "Days" as excluding an in-service day that a retired teacher must

attend in order to serve as a substitute teacher. The in-service days do not involve classroom teaching and therefore do not constitute re employment as a "teacher," as referenced in Section 17-149 of the Pension Code.

Section III.E.107 of the Return to Work Rules, "Definition of a Day," has been changed to include the section italicized below:

III.E.107 Definition of a Day. For purposes of this Article, a retiree shall be deemed to have worked a "day" when an Employer reports the retiree worked for compensation as a Teacher for at least one hour in any calendar day. However, a "day" shall not include an "in service" day that the retiree must attend in order to qualify as a substitute.

## myCTPF Member Self-Service Available

Join the thousands of members who have registered for myCTPF, the Member Self-Service portal. Members who register for myCTPF create a unique User ID and password. Once an account is created, members can use myCTPF to securely access CTPF documents and information.

Registered members can:

- View address/contact information on file with CTPF.
- Retirees can view and download a 1099-R and pay advice(s). Members who need replacement copies of their 2020 1099-R can download them from the portal after registering.
- Active and inactive members can view and download their annual Member Statement.

Access the system from a "button" at <a href="mailto:ctpf.org">ctpf.org</a>, and you must have a CTPF Member ID to register. Two-factor authentication ensures secure access. Active members can find their CTPF Member ID on the Member Statement. Retirees can find their Member ID on a pay advice from the Fund.

Each pay period, Employers remit employee pension contributions to CTPF. Illinois law requires that these contributions be made within a certain time period.
