Voting Closes Today in 2022 Trustee Election

Voting in the CTPF Teacher and Principal/Administrator elections opened October 17, 2022, and closes at **5:00 p.m (CT), today, November 4, 2022**. Voting credentials were mailed to members' home addresses, and YesElections, the Fund's election agent, sent emails with voting credentials to members with emails on file. All voting will be conducted online.

2022 Credentials Form - CTPF is updating the name of the Pension Rep at each school for the 2022 election. If you intend to return as Pension Rep for this year, please complete the 2022 Credentials Form, noting any necessary corrections or updates, and return to CTPF by email to pensionreps@ctpf.org or Fax to 312-641-7185. Even if you do not have changes, please return the form so that we know you will continue to serve. If you are retiring or do not intend to serve in this position for the upcoming school year, please seek a volunteer or ask your principal to appoint a replacement. The person selected must be a certified teacher.

2022 Attestation Form - Pension Representatives who assist with the 2022 Teacher Trustee election are eligible to receive \$50 for attending/viewing the election webinar, and an additional \$50 for sharing information with colleagues. You must complete and return an attestation form to receive payment. Please return this form to CTPF NO LATER than **Friday, November 18, 2022**, to receive your stipend check in December. All attestation forms received after November 18, 2022, will be held for a second round of stipend payments to occur in the new year.
