Thank you for serving as your school's Pension Representative. Pension Reps provide a valuable link between schools and CTPF and we appreciate your assistance throughout the year.

This fall, CTPF will hold elections for Two Teacher Trustees who will serve three-year terms from November 2023-2026 and three Pensioner Trustees who will serve two-year terms from November 2023-2025. All eligible voters will receive a unique voter identification number by mail and, if available, by email. Online voting will open the day materials are mailed, the week of October 16, 2023. Voting closes on November 3, 2023, at 5:00 p.m. (CT).

Signatures may be collected with paper petitions, using the online digital collection system developed by the Election Agent, or a combination of both methods.

Submitting Completed Nomination Packets: A candidate's signed nomination petition(s) must be received by the Election Coordinator or his/her designee, on behalf of the Recording Secretary, by U.S. Mail, email, or facsimile. Signatures submitted online using the secure portal will automatically be remitted to CTPF.

The Fund reserves the right to request a candidate's original nomination petitions. Petitions must be returned by September 29, 2023, at 5:00 p.m. (CT).
