Members who register in advance (see deadlines above) will receive a pension estimate via mail to the address on file. Please make sure your address on file is up-to-date by logging on to myCTPF or by calling Member Services at 312.641.4464.

PREPARING FOR RETIREMENT

Here are a few steps to take now if you plan to retire in 2023:

- Register early for a CTPF Retirement Webinar. If you register by February 10th for the February 20th webinars, or by March 24th for the April 4th webinars, CTPF will provide you with a pension estimate, if applicable.
- Download and refer to the retirement checklist in the Application for Service Retirement for a list of all required documents The application can be accessed online at <u>ctpf.org/retirement-resources</u>.



- Collect or obtain the required personal identification documents listed on the checklist. Missing documentation will cause processing delays.
- Member Services offers remote notarization for CTPF documents, in accordance with Illinois law. Members who would like assistance notarizing CTPF documents should call or email Member Services at 312.641.4464 or email memberservices@ctpf.org, and request a videoconference for notarization.
- Check your most recent Member Statement (or download it from *my*CTPF) and confirm that your personal information is up-to-date. Address and demographic changes need to be made with your employer. Find more information at ctpf.org/annual-member-statement.
